Mental Health Services For Children & Adolescents



Mission:
 “To provide help and hope to all who strive to overcome challenges associated with mental illness, alcohol and chemical dependency, intellectual and developmental disabilities within our community”

Eligibility Criteria

As the Local Mental Health Authority, Pecan Valley Centers provides mental health services for youth ages 3-18 years old who have a diagnosis of mental illness and exhibit serious emotional, behavioral, or mental disorders and who:

- ◇ Have a serious functional impairment; or
- ◇ Are at risk of disruption of a preferred living or child care environment due to psychiatric symptoms; or
- ◇ Are enrolled in a school system's special education program because of serious emotional disturbance

Pecan Valley Centers will work to deliver treatment based on the youth's needs, strengths, and complexity of needs in order to accomplish "Hope, Resilience, and Recovery for Everyone"

Services Include:

- ◇ Counseling
- ◇ Routine, intensive, and family case management
- ◇ Psychiatric Evaluation
- ◇ Medication training and support
- ◇ Individualized treatment planning
- ◇ Behavioral skills training
- ◇ Parent support groups & family training
- ◇ Flexible funds
- ◇ Specialized Parent Skills Training

Services Determined By:

- ◇ The child/adolescent's eligibility for programs
- ◇ The needs of the child/adolescent identified by the treatment team
- ◇ Treatment team includes the child/adolescent, a parent or guardian, and designated Pecan Valley Center staff members

How to Access Services:

Payment for Services:

- ◇ Fees determined on a sliding fee scale
- ◇ Medicaid, CHIP, or third party payers if eligible
- ◇ If these resources have not been accessed, Pecan Valley will assist in securing these resources
